Teachers new to Seminole County will be initially placed on the salary schedule based upon previous years of verified experience up to the maximum provided on the teacher salary schedule. Effective July 1, 2011, employees contribute 3% of their salary and degree supplement as retirement contributions on a pre-tax basis. Senate Bill 736, Advanced Degrees - A district school board may not use advanced degrees in setting a salary schedule for instructional personnel or school administrators hired on or after July 1, 2011, unless the advanced degree is held in the individual's area of certification and is only a salary supplement. The 2011-12 Teacher Salary Schedule will be posted upon completion of negotiations and approved by the Board.
